District Councillors' report February 2025

As you will all no doubt be aware, the government have announced that Norfolk will be amongst the first wave of District Councils to be invited to propose arrangements to become a Unitary authority or authorities and that will see the dissolution of all district councils in Norfolk. Meanwhile Breckland continues as an elected council to provide all the services required of it until such time as Parliament passes the appropriate legislation for change.

Much has been written about the topic, but the common theme is undoubtedly the undue haste with which this major change is proposed; the County and Districts are required to produce unified proposals by the middle of March some 6 weeks or thereabouts after government made the announcement.

An unbiased view of the above is provided as the Opinion in the EDP today, February 12th, under Peter Franzen's byline and in particular the comparison timeline of 3 years, which the 1974 reorganisation took and the relative size of the Unitary authority that is proposed to be a minimum population of 500,000 with little or no recognition of the size of the county or its geography and road networks.

The second element of the government's proposals to 'reform' local government revolves around the election of a Mayor for Norfolk and Suffolk in whose control will be vested such diverse functions as strategic planning and taxi licensing. It is somewhat challenging to grapple with the ability to fulfil such diverse functions across two counties the sizes of Norfolk and Suffolk and retain intimate detailed knowledge of both in order to arrive at a balanced and considered decision making process. Nevertheless, this initiative has commenced and the Mayor is to be elected in May 2026. For those interested in the detail please refer to gov.uk web pages relating to devolution and the mayoral elections.

In light of the publication of the draft White Paper by MCHLG Breckland has taken the decision to pause further work related to the proposed introduction of car park charges pending the establishment of a new authority that would assume responsibility for Breckland's assets, car parks being one component.

Council on the 20th of February will focus on the budget setting for the coming year and the proposed increase in council tax that would see the band D charge rise by £4.95 p.a. to £118.53p. This will retain Breckland's enviable position of charging the lowest district council tax in Norfolk and the country whilst providing all of the statutory services we are obliged to provide and the many discretionary functions that we fund that are so valuable and in many cases, essential, for our residents, communities, groups and businesses. All of this without resorting to borrowing unlike many other authorities.
